

## **CLASSES OF MEMBERSHIP**

### **May 1, 2011**

All golfing members pay a \$3.00 per round user fee.

#### **GOLF MEMBER – Option 1**

Capital Investment Fee: \$50/month - fixed for the duration of membership up to 20 years.  
Each Golf Member must be at least twenty-one (21) years of age. A Golf Membership includes the member's spouse and the member's single sons and/or daughters under twenty-one (21) years of age or until twenty-three (23) years of age if still in school. The member may switch to Option 2 (see below) at any time by paying the then-applicable lump sum Capital Investment Fee.  
Annual Dues (May 1, 2011 thru April 30, 2012): \$4,080 – billed at \$340 per month.  
Total Monthly Combined Fees: \$390 per month  
Annual Food Minimum: \$600

#### **GOLF MEMBER – Option 2**

Capital Investment Fee: \$6,000 - payable within thirty (30) days of acceptance by the Board.  
Each Golf Member must be at least twenty-one (21) years of age. A Golf Membership includes the member's spouse and the member's single sons and/or daughters under twenty-one (21) years of age or until twenty-three (23) years of age if still in school.  
Annual Dues (May 1, 2011 thru April 30, 2012): \$4,080 – billed at \$340/month.  
Total Monthly Combined Fees: \$340 per month  
Annual Food Minimum: \$600

#### **SEASONAL GOLF MEMBER**

Capital Investment Fee: \$50/month - fixed for the duration of membership  
The Seasonal Golf Member, spouse and their children are unrestricted in their year – round use of the Club House, Tennis Courts, and Swimming Pool. The membership also provides for unrestricted golf from May 1<sup>st</sup> until September 30<sup>th</sup>. No golf privileges, even as a guest, are afforded from October 1<sup>st</sup> until April 30<sup>th</sup>. During the Test Market period the Seasonal Golf Member may not vote and/or serve on the Board.  
Annual Dues (May 1, 2011 thru September 30, 2011): \$2,500 – billed at \$500 per month.  
Total Monthly Combined Fees: \$550 per month  
Annual Food Minimum: \$600

#### **UNDER-40 MEMBER**

Capital Investment Fee: None  
The Under-40 Member must resign or convert to Golf Member status under one of the above options within thirty (30) days of his/her fortieth (40) birthday, pending approval by the Board. The Under-40 Member, spouse, and their children shall have all privileges afforded by the Club except the right to vote and serve on the Board. Under-40 Members may not exceed 25 at any time; a wait list will be maintained. If the membership includes a spouse or significant other, the qualification for the Under-40 Membership ends when the younger person reaches age 40 or when the older person reaches age 45, whichever occurs first.  
Annual Dues (May 1, 2011 thru April 30, 2012): \$2,736 – billed at \$228/month.  
Annual Food Minimum: \$600



**SOCIAL MEMBER**

Capital Investment Fee: None

Social Members are unrestricted in their use of the Club House, Tennis Courts, and Swimming Pool, and may play up to 5 rounds of golf per year at the prevailing Accompanied Guest green fee.

Annual Dues (May 1, 2011 thru April 30, 2012): \$1,020 – billed in 4 installments (March – June)

Annual Food Minimum: \$150

**WINTER SOCIAL MEMBER**

Winter Social Memberships are available from October 1st through March 31st for a nominal fee of \$25.

This membership entitles you to full access to Clubhouse and Dining facilities as well as any special events.
